PREFACE

Though the profitability is usually primary objective of every industrial organization yet, the attainment of national self-reliance in health care and service to the humanity through production of quality drugs, are the other factors which led us to the establishment of a model pharmaceutical manufacturing unit in Pakistan.

Benson Pharmaceuticals was formed in 1995 but construction of the manufacturing facility started in last quarter of 1996. By the grace of God, guidance of Drug Regulatory Authority of Pakistan and with technical support of a team of professionals, machines at Benson's first manufacturing facility started rolling at the end of last millennium i.e. December 2000. Today Benson Pharmaceuticals stands right in the heart of Islamabad, the capital city of Pakistan. Our second manufacturing facility was inaugurated in the beginning of 2019 at National Industrial Zone, Rawat.

Since its establishment, Benson has made its presence felt in the pharmaceutical industry of Pakistan with production of quality drugs at affordable prices. Our product range includes various therapeutic classes of drugs like non-steroidal anti-inflammatory pain killers, anti-ulcerants, antibiotics, antibacterial, antiemetic, vasodilators, antihypertensive and cephalosporins in common dosage forms i.e. Tablets, Capsules, Dry Powder Suspensions, Sachets and Injectables (IM/IV).

Benson Pharmaceuticals is well knitted in a web of field force and distribution houses across Pakistan. Besides we are also registered as a potential source of quality drugs & medicines with all major pharmaceutical consuming institutions of Pakistan including, but not limited to, Defense Forces of Pakistan, all Provincial Governments, various health programs operated by Federal and provincial governments, various cardiology institutes and all major public/private sector hospitals including teaching hospitals. Our quality products are exported to Afghanistan, Cambodia, Vietnam, Philippines, Srilanka, Myanmar and Republic of Yemen whereas registration process with Regulatory Authorities of various other countries is in progress.

The resilience and foresightedness of the company has allowed the second generation to take active part in the management. Benson, therefore, continues to operate with the same spirit and conviction as ever, never forgetting the primary objective of producing drugs & medicines of internationally recognized pharmaceutical standards at affordable prices. In its ef forts to conform to the latest pharmaceutical protocols & to cope with the regular updation process of various local and international regulatory requirements, Benson Pharmaceuticals has obtained the certification of CGMP on WHO format, ISO 9001-14001 & 18001. Benson Pharmaceuticals follows CGMP (Current Good Manufacturing Practices) and GLP

(Good Laboratory Practices) to ensure the attainment of its mission statement "ECONOMY BUT NOT AT THE COST OF OUALITY"

Benson Pharmaceuticals is one of the very few pharmaceutical companies in Pakistan, which has been registered with Environmental Protection Agency of Pakistan (EPA), meaning thereby we have zero tolerance on polluting the natural environment.

In order to address the ever growing demand of our quality products, the second state of the art manufacturing facility of Benson Pharmaceuticals, under same name and Drug Manufacturing License, was inaugurated in January 2019. The new plant is situated at National Industrial Zone, Rawat, Rawalpindi and is fully operational now.

PRODUCTION

Benson Pharmaceuticals prides itself with massive production capacity, while complying not only with scheduled time frame but also complete adherence to the documented SOPs and procedures. All production machines and equipment are designed to meet the requirements of CGMP.

Not only production machines and equipment are calibrated and validated at regular intervals but also products and all production procedures too are validated. Twenty seven air handling units, serving various production areas and sections, leave no room for cross contamination.

Regular training programs are scheduled for senior and junior staff to be in step with latest regulatory requirements at every level. Preventive maintenance schedules are followed. Medical fitness tests for all production staff are undertaken twice a year. Disposal of production wastage is so designed that zero wastage is sent out in the environment.





QUALITY CONTROL

Quality control, undoubtedly is the essence of every product but it becomes unavoidably more important when production of life saving drugs is involved.

At Benson, quality cannot be compromised at any cost because not only precise tests/analysis of every product, at every step are conducted but also records along with auto generated prints are made a part of production process.

Safety, stability & efficacy of the products is ensured from procurement of products' components till one year beyond the expiry date. Entire process of production, safety, stability & efficacy is monitored by highly qualified and experienced professionals, never forgetting the mission statement

QUALITY ASSURANCE

Our manufacturing unit is equipped with the most advanced analytical equipment supported by adaquate documentation to monitor and control manufacturing processes. Our quality assurance personnel remain on their toes to ensure compliance

to cGMP during production.



Rigouros training sessions are perioically held by our Quality Assurance Department to ensure complete compliance with pharmaceutical standards and regulatory requirements.

Quality Assurance functions independently to achieve the following objectives:

- Assure quality production through inprocess sampling, inspection and testing throughout the process.
- Ensure that SOPs are properly followed by each department.
- Ensure that the products are meeting all the required standards and specifications during the manufacturing, packaging and storage processes.
- Conduct training of all quality assurance personnel to achieve quality objectives.
- C o n d u c t p o s tmarketing surveillance by product sampling from the shelves of pharmacies to ensure consistant efficacy.





MICROBIOLOGY

Microbiology laboratory is the vital part of pharmaceutical industry in the modern era and hence is true for Benson Pharmaceuticals. Testing of sterile as well as Non-sterile dosage forms as per standard procedures is mandatory so that contamination free products are supplied to the end user.



At Benson Pharmaceuticals, we have well furnished microbiology laboratory with highly skilled professionals duly equipped with state of the art instruments for the various microbiological testing of sterile products, Area monitoring, water testing and LAL (Litmus Amoebocyte Lysate) for Pyrogen testing. Sterility testing of the finished products is performed to ensure the sterility of the parenteral products prior to their delivery to the market.








STORAGE

Our storage facility comprises General Raw Material store, Cephalosporins Raw Material store, Packing Material store, finished goods store, various quarantining areas, six dispensing areas, controlled recall rooms, detained store, and rejected material rooms. Storage facility is spread over an area of ten thousand Sq. FT. Temperature/Humidity conditions in the storage areas are maintained as per pharmaceutical standards. The temperature and humidity conditions are recorded at set intervals & charts displayed accordingly. The storage area is



supervised by a duly qualified pharmacist. All the requirements of GSP (Good Storage Practices) are complied with. FIFO (first in first out) system for the issuance of materials is followed.

Receiving and dispatch bays protect materials and products from the weather. Reception areas are designed and equipped to allow containers of incoming materials and pharmaceutical products to be cleaned, if necessary, before storage.

Storage areas are ensured to be clean, and free from

the methods to be used to clean the premises and storage areas. There is also a documented program for pest control. The pest-control agents used are ensured to be safe, and that there is no risk of contamination of the materials and pharmaceutical products. Appropriate procedures for the cleanup of any spillage to ensure complete removal of any risk of contamination are available.

There is a separate sampling area for starting materials in a controlled environment. If sampling is performed in the storage area, it is conducted in such a way as to prevent contamination or cross-contamination. Adequate cleaning procedures are in place for the sampling areas. Rejected materials and pharmaceutical products are identified and controlled under a quarantine system designed to prevent their use until a final decision is taken on their disposal.

Physical or other equivalent validated segregation is provided for the storage of rejected, expired, recalled or returned materials or products. The materials or products, and areas concerned are appropriately identified.








AIR HANDLING SYSTEM

The production facility is equipped with twenty-seven Air Handling Units (AHUs). These units leave no room for cross contamination. Besides automatic operation of these units ensures required level of temperature & humidity at all times. All Air handling units are validated to their designed functions at least twice a year. Filters are cleaned/replaced as per standard operating procedure. Preventive maintenance of all units is scheduled in the beginning of every calendar year & implemented religiously.



Materials for components of the HVAC system were selected with extreme caution so that they do not become a source of contamination. All ventilation dampers, filters and other services are designed and positioned so that they are accessible from outside the manufacturing areas (designated technical floor) for maintenance purposes.

Directional airflow within production or primary packing areas is designed in a way to assist in preventing contamination. Airflows are planned in conjunction with operator locations, so as to minimize contamination of the product by the operator and also to protect the operator from dust inhalation.



WATER TREATMENT PLANT

M FNVIRONMENT

One of the biggest challenges that confronted the humanity this millennium is the climate change. Wild industrial growth of developed world, unchecked pollution emitted by developing countries, industrial waste & population growth are the main factors which contributed to climate degradation. Being a

responsible industrial unit, Benson Pharmaceuticals is one of the few Pakistani pharmaceutical industry which got itself registered with environment Protection Agency (EPA) of Pakistan to ensure it does not contribute to this major universal problem. Benson Pharmaceuticals follows the policy of zero tolerance on pollution to the environment. No manufacturing waste is allowed to be mixed with the environment. Cycle able waste is sent to relevant manufacturing units for reuse, noncycleable waste is burnt in controlled conditions, ash mixed with cement to make construction blocks. These blocks are then used for the expansion/construction purpose. Chemical waste is collected through chemical resistant pipes and stored in a septic tank. Samples out of the tank are analyzed in the laboratory, neutralized & only then released for out flow.



SOCIAL DEVELOPMENT

Benson Pharmaceuticals believes in sharing the prosperity with its employees & the community. in fact, every industry is indebted to the local community for the business opportunity provided around.

Benson Pharmaceuticals religiously devotes a fixed percentage of its net earnings for the social development program. Towing this policy, Benson has chosen village Chajana, the remotest village of District Rawalpindi, the district in which we are situated, for its social development program. We have made considerable contribution for the development of road network, electrification & clean drinking water network for uplift of this remote village.
